Foundation, Capital Place LLC and Ice Rink Events, and all sponsors of the ice rink establishment and their subsidiaries, affiliates, partners, officers, directors, employees, agents, and volunteers arising out of Participant's use of the ice skating rink and all surrounding areas.

Participants and/or their parent(s) or guardians hereby release and hold harmless Conagra Brands, Inc, Conagra Brands Foundation, City of Omaha, Downtown Omaha, Inc., Downtown Omaha, Inc.
